

Please see attached the recently passed **House Bill 7031** for the state of Florida. This is now state law. I have highlighted the important section of note below, but for reference, see pages 8 and 9 on the attached document.

125.0104 Tourist development tax; procedure for levying; authorized uses; referendum; enforcement.—

- (5) AUTHORIZED USES OF REVENUE.—
- (a) All tax revenues received pursuant to this section by a county imposing the tourist development tax shall be used by that county for the following purposes only:
- 7. To employ, train, equip, insure, or otherwise fund the provision of lifeguards certified by the American Red Cross, the Y.M.C.A., or an equivalent nationally recognized aquatic training program, for beaches on the Gulf of America or the Atlantic Ocean
