
### Call to Order, Welcome and Introductions

### Communications

Tyler Anderson- President on International Lifeguard Critical Incident Response Critical Incident Stress Response, assess how critical incident stress management works with lifeguards. Pilot teams in each state train people who can work across agencies.

Ian Montgelas- Swim Near a Lifeguard Campaign Billboards-Passed out picture of the impact on the state. Discussed email from the you-safe demonstration. Reaching out to different organizations for robotic rescue device testing at beaches.

Chief Pingol Fort Lauderdale Deputy Chief Fire Rescue- Gratitude for Ocean Rescue and talking about biggest asset to integrating ocean rescue into fire department at Fort Lauderdale. Talked about how the response times for major incidents on the water for ocean rescue has been much faster for critical incident response. Talked about dual roles in the future for ocean rescue/firefighters. Integrating fire and Ocean Rescue together.

Gerry Falconer- News of drownings up and down coast, talking about closing beaches. Talked about extending hours and keeping lifeguards on the beach. Specifically in New Jersey, Belmar and Seaside Heights.

John Meskiel- Talking about news being on him about beach closures to include peanut island. Don't have the staffing to keep certain beaches open. Even with new positions, cannot open certain parks, even after drownings.

Bob Mahler- Talked about not having the budget to have people stay an extra hour after closure to prevent beach drownings. Figuring out certain days to have people for the extra time when lifeguards are off shift. Talking about holiday weekends being open later as a start. Passing out the surf lifesaving banquet pamphlets for those who didn't attend.

### **Ian Montgelas President-**


- Received two applications for training officer academy USLA. Due date September 1<sup>st</sup>.

### **Ramo Cline: Hollywood Beach –**


Still a little short staffed, two new lifeguards started

  - City is proposing exclusion buoys at 100 yards off, lifeguards don't want this, but city is addiment.

### **Mike Huck: Dania Beach –**

- All salaries city wide brought up by 20%
- Have a tough time with quality applicants
  - Harder time hiring the younger generation
    - Losing a lot of the younger guys to physical fitness tests
- Idea of salary teams to go to city commissions to help increase salary

- Recently they went to the 4x10 schedule year-round
  - 4x10's has decreased overtime, and they have gotten an additional 2 full-timers
- Almost full staffed just need one more position to fill.

- In dire need of lifeguards
  - 6 people signed up for the last test and only 2 showed up
    - The two that did show up were unprepared and did not pass the swim test Relax some of the requirements as far as Part-Time EMT
    - Last week, 4 out of 8 towers were vacant
      - Looking for part-timers
      - Relaxing EMT for part-timers


## **Mathew Sparling-Miami-Dade County-**

  - Still will be full despite this.

## **Mark Fitchner: Lantana Beach, Central VP-**

- Only department in whole town that didn't get budget cut and got increase
  - Funded to buy scuba equipment, will be certifying 4 employees in Emergency Response Diver 1 and purchasing two scuba apparatuses
- Will be a private course if any lifeguards in our area interested let me know.
- Installing new swim buoys
- Architects and engineers were hired to begin the re-visioning on the public beach, knocking everything down and building new restaurants, facilities, towers and access ramps
  - 1 year will have blueprint, 2 years will be starting the North end, and 3-4 years south end.
- Began mechanical Beach Raking August 15<sup>th</sup>







## New Business


